TERMS AND CONDITIONS

- 1 Charter rates inclusive of captain's fee, provision of a skipper, and fuel for cruising up to 3 Hours.
- 2 Chartered yachts are barefoot boats so no shoes on inner deck.
- 3 Maximum number of guests allowed on board: 12 persons; a child or baby is considered as 1 person.
- 4 Payments to be made by cheque, cash or credit card only; no credit terms allowed.
- 5 Charter cancellations: With effect from date that notification of your cancellation is received in writing or by email.
